AN ORDINANCE TO AMEND CHAPTER 285 ENTITLED "ZONING" TO AMEND SECTION 285-22 ENTITLED "M-1 INDUSTRIAL DISTRICT" PARAGRAPH "C" OF THE VILLAGE OF DICKEYVILLE MUNICIPAL CODE.

NOW, THEREFORE, the Village Board of the Village of Dickeyville, Grant County, Wisconsin, does ordain as follows:

<u>Section I:</u> Chapter 285 entitled "Zoning" Section 285-22 entitled "M-1" Industrial District" Paragraph C of the Village of Dickeyville Municipal Code shall be and hereby amended as follows:

§285-22 M-1 Industrial District.

C. Building Height: maximum 100 feet.

Section II: This Ordinance shall take effect upon its passage and publication or posting as required by law. Adopted and approved this 10th day of January, 2024, by the Village Board of the village of Dickeyville, Grant County, Wisconsin.

We are looking into the waste bags and garbage bins just for this. PLEASE if you take your dog to the park pick up their waste.
