

Unapproved Minutes of the Regular Board Meeting

The Dickeyville Village Board met in Regular Session on November 12, 2025, at 6:00 p.m. in the Dickeyville Community Center, 500 East Avenue, Meeting Room A.

CALL TO ORDER: The Meeting was called to order at 6:00 p.m.

APPROVE: Minutes of October 15, 2025, Regular Board Meeting. MOTION: Timmerman and Ginter approve the minutes of October 15, 2025, regular board meeting. Approved.

1. DISCUSSION AND POSSIBLE ACTION ON: Scott Wright would like to talk about a donation to the Dickeyville Junior Bowling League. Scott stated that we, as a board, have been donating to the Junior Bowling League. Scott is asking the board if they would like to donate again this year. The BINGO group will donate \$500.00 to the Junior Bowling League.

MOTION: Ginter and Leibfried donate \$500.00 to the Junior Bowling League. Approved.

2. DISCUSSION AND POSSIBLE ACTION ON: Proposed 2024 Park Improvements – Dickeyville Community Park.

a. Pay application #4 and Change Order # 3 – Owen’s Excavating & Trenching, Inc., The Community Park project was completed in May 2025. Everything has been approved. There are some lien waivers that Delta 3 is waiting on. MOTION: Leibfried and Ginter to approve Pay #4 and Change Order #3 contingent on the final lien waivers. Approved.

3. DISCUSSION AND POSSIBLE ACTION ON: Dickeyville Well #3 Project Funding. The Village received a Grant for \$819,000.00, and we can take out a loan from the Clear Water Loan for the rest of the project at a 2.8 percent interest rate for 20 years. Bart wanted to know if the Village wanted to proceed with the project. MOTION: Timmerman and Ginter to have Delta 3 start the project. Delta 3 will submit plans in May and may take more than a year for construction. Approved.

4. Bart wanted to know if the Village was planning to pave any streets in the Village next year. The Board would like to do North Church Street. We can use the LRIP money, and Delta 3 can apply for a Grant from CDBG. We will have to do a Survey of the neighborhood, like we did on S. Church Street.

5. DISCUSSION AND POSSIBLE ACTION ON: How to proceed with BINGO. We are asking for volunteers to help once a month at BINGO. If Chief Reuter or Donna Retires, we will not have people to step up. If you know of anyone who would like to volunteer, please let us know.

6. DISCUSSION AND POSSIBLE ACTION ON: Gardiner Appraisal Service Contract. MOTION: Redfern and Timmerman to accept the Gardiner Appraisal Contract for next year. Approved.

Fire Sirens. North Center Street does not work all the time. Luke talked with J. Bechen from Ray Com, and he will let us know what it will cost to replace them. We discussed with Beschen about a large round siren. Will have on next month's agenda again.

CLERK'S REPORT:

- A. Park and Community Center Committee sent in a Grant for flooring for the gym and hallway. We included gutters and downspouts, and snow stops for the roof. We may not hear anything till spring.
- B. DISCUSSION AND POSSIBLE ACTION ON: Budget. We can schedule the meeting for December 3, 2025 at 5:30 p.m.
- C. DISCUSSION AND POSSIBLE ACTION ON: Rate increase for the Community Center gym and kitchen, along with the pavilion in the park. The upper Pavilion will not be rented out till after Labor Day. The

Committee is asking the board to approve the rate increase of: Gym and kitchen from \$100.00 to \$150.00, with the deposit going from \$50.00 to \$100.00. The Parks would be going from \$25.00 to \$50.00, and the deposit for parks will be going from \$25.00 to \$50.00. For Room A, rent will go from \$25.00 to \$50.00 with \$50.00 deposit. The Board approves the rate increase for the Community Center and the Parks starting January 1, 2026.

- D. Nomination papers can be picked up at the Village Office starting December 1, 2025, and they need to be back in the Clerk's Office on January 6, 2026, by 5 p.m.
